Requests for positions at the preschool will be compiled into the basic list by the Eastmont Pre-School recording the name and other basic data as per the following selection criteria.

4 YEAR OLD APPLICANTS:

- 1. ELIGIBILITY** - For entry into a four year old group: A child must have turned four years old by April 30 to coincide with school entry.
- 2. REPEATING CHILDREN** - Children who require a second year of Pre-School as recommended by the Director/Teacher.
- 3. TEACHER ADVISED DEFERRAL**
- 4. 3/4 CONTINUITY** - Applicant has attended the Pre-School in the previous year.
- 5. SIBLINGS** - Brothers/Sisters of previous or current attendees at the Pre-School.
- 6. PROXIMITY** - The applicant's current residential address is closer to Eastmont Pre-School than other applicants.
- 7. PARENT DEFERRAL** - The applicant has been offered a place at Eastmont Pre-School for the current year, but the parents/guardians have decided not to accept the position and choose to carry it over to the following year.
- 8. DATE RECEIVED** - This date will be the date recorded by Eastmont Pre-School relative to the child's 2nd birthday.
- 9. SPECIAL CIRCUMSTANCES** - Any special circumstances which the committee feels are appropriate to consider and are not covered by the Selection Criteria and will be considered on a case by case basis.

3 YEAR OLD APPLICANTS:

- 1. ELIGIBILITY** - For entry into a three year old group: A child must have turned three years old by April 30 to coincide with school entry. A child must be three years of age before they can commence the program as per DEECD Regulations.
- 2. TEACHER ADVISED DEFERRAL**
- 3. REPEATING CHILDREN** - Children who require a second year of Pre-School as recommended by the Director/Teacher.
- 4. SIBLINGS** - Brothers/Sisters of previous or current attendees at the Pre-School.
- 5. PROXIMITY** - The applicant's current residential address is closer to Eastmont Pre-School than other applicants.
- 6. PARENT DEFERRAL** - The applicant has been offered a place at Eastmont Pre-School for the current year, but the parents/guardians have decided not to accept the position and choose to carry it over to the following year.
- 7. DATE RECEIVED** - This date will be the date recorded by Eastmont Pre-School relative to the child's 2nd birthday.
- 8. SPECIAL CIRCUMSTANCES** - Any special circumstances which the committee feels are appropriate to consider and are not covered by the Selection Criteria and will be considered on a case by case basis.
